ST. ANN SCHOOL PRE-K-6TH GRADE REGISTRATION INFORMATION

Dear Parents,

Thank you for having chosen St. Ann School for your child. Your choice of St. Ann School shows your dedication to education, family and faith development. We are grateful for your continued involvement in your child's education. Registration begins **February 1, 2011**.

A registration fee of \$100.00 is charged per family with children in Grades K-6 and a registration fee of \$75.00 is charged per family with Pre-K children ONLY and must accompany your registration form. Registration forms returned by February 11, 2011 are eligible for a waived registration fee. Verbal commitments do not guarantee enrollment for your child.

We have tuition assistance and scholarship funds available for any family that applies and qualifies, with children in K-6th Grade.

Through support from Our Lady of the Valley Parish, support from other parishes that send children to our school, funding from New York State, donations from friends and alumni of St. Ann School, and **your fundraising efforts**, our tuition is one of the lowest in the Diocese. Below is the tuition schedule for 2011-2012:

Parish Sponsored – 1 child	\$2,300
Parish Sponsored – 2 children	\$3,600
Parish Sponsored – 3 children	\$4,500
Parish Sponsored – 4 + children	\$5,000
Non-Parishioner – 1 child	\$2,785
Non-Parishioner – 2 children	\$4,000
Non-Parishioner – 3 children	\$5,000
Non-Parishioner – 4+ children	\$5,550

Pre-K tuition (3 & 4 year old programs) is not included in the tuition rates above. Full-time Pre-K tuition is \$2,800 per year, part-time Pre-K tuition is \$1,800 per year. Pre-K tuition can be claimed as a Child Tax Credit on your Income Tax Returns.

The registration forms and fee (after February 11, 2011) need to be returned to school as soon as possible to facilitate budget planning and textbook ordering which is done through the respective local school districts. Screening for all children entering Kindergarten in the fall will be conducted in May. Details will follow closer to that date.

Transportation requests must be made to your local public school district before **April 1, 2011**. Presently, four local school districts transport St. Ann School students:

Hornell, Canisteo-Greenwood, Arkport and Dansville. The following school districts have transported students in the past: Canaseraga, Alfred-Almond and Wayland-Cohocton.

Request for Bus Transportation forms are available in the school office. St Ann School will forward the forms to your local school district on your behalf. Please remember the final decision to transport students rests with your local school district.

For anyone that has a financial need (K-6th Grade), scholarships and grants are available. Subsidy amounts vary according to need. All who apply and qualify for assistance will be helped. Tuition assistance packets are available in the School Office. If you are interested in applying for funds, please stop in or let us know and we will forward an assistance packet to you. Completed applications for tuition assistance are due by **May 15, 2011**.
